### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as MoU) entered into on this day ...20<sup>th</sup> November, 2020.


### BY AND BETWEEN


**THE National Institute of Technical Teachers Training and Research, Chandigarh**, is one of four NITTTRs established in the year 1967 by Ministry of Education (formerly Ministry of Human Resource Development), Government of India to meet the requirements of developing technical education in the country mainly in the northern region, covering the states of Himachal Pradesh, Punjab, Haryana, Rajasthan, Uttar Pradesh, Uttarakhand, Delhi and Union Territory of Chandigarh, Jammu and Kashmir and Ladakh, herein after referred as **NITTTR, Chandigarh**.

### AND

**STATE INSTITUTE OF RURAL DEVELOPMENT AND PANCHAYAT RAJ (SIRD&PR)**, Government of Tamil Nadu at Maraimalainagar, under Rural Development and Panchayat Raj Department, Government of Tamil Nadu is conducting Training, carrying out Research and Consultancy Services in the Rural Development Panchayat Raj and related areas, in collaboration with Regional Institutes of Rural Development and District Administration, herein after referred as **SIRD&PR, Tamil Nadu**.

The aforesaid Institutions are hereinafter referred to individually as Institution and collectively as Institutions.

## WHEREAS

A. **NITTTR, Chandigarh** is an ISO 9001-2015 certified institute with several objectives viz. training teachers of polytechnics and Engineering Colleges through different types of courses, fostering and promoting research in improving classroom and laboratory instruction, preparing and supplying instructional materials including e-sources, associating with other academic bodies of technical education to achieve quality improvement in academic programmes, collaborating with institutions and organisations in India and abroad having similar objectives and functions, and interacting with industries in formulating training programmes of mutual interest.

B **SIRD&PR, Tamil Nadu** as part of its capacity building of various primary and secondary stakeholders involved in Rural Development and Panchayat Raj (RD&PR) Programmes / Schemes implemented by the RD and PR Department, Government of Tamil Nadu (GoT), research and consultancy concerning with RD & PR activities in rural Tamil Nadu.

In consideration of mutual agreement contained herein, the Institutions do hereby broadly agree as follows:

### 1. NOW THEREFORE THIS MoU WITNESSES AS UNDER:

The NITTTR, Chandigarh and SIRD&PR, Tamil Nadu will work together and involve themselves for undertaking activities and programmes in the following domain areas

- 1.1 Collaborative Trainings, Seminars, Workshops on relevant topics and issues etc.
- 1.2 Faculty Development Programmes for both Institutions
- 1.3 Conduct of Research studies on mutual agreement
- 1.4 Carrying out Programme Evaluation and Consultancy on mutual areas of Interest
- 1.5 Documentation of Case Studies on Best Practices and its dissemination
- 1.6 Networking with Institutions working for Rural Development & Panchayat Raj etc.


### 2. BOTH INSTITUTIONS SHALL AGREE UPON THE FOLLOWING:

- 2.1 Preparing and finalizing annual action plan
- 2.2 Contribution in terms of financial resources, human resources, physical infrastructure facilities and any other resources shall mutually decide on case to case basis
- 2.3 The rates applicable for Government Institutions such as GST/ Income tax / Institutional Fee / Consultancy Charges / Faculty cost / logistics and other eligible expenditure may be charged by both Institutions.

**3. COORDINATION:** Senior Level Representative for each Institution shall be nominated as Nodal Officer for facilitating the implementation of Annual Action Plans regularly.

4. **AMENDMENT:** This MoU may be amended, from time to time depending on the need, on mutual agreement by the both Institutions.


5. **CONFIDENTIALY and NON-DISCLOSURE INTELLECTUAL PROPERTY RIGHTS:** Any software / hardware material, presentations / product specifications, financial information, documents covered under this agreement shall be deemed to be in private domain and it shall not be made public or shared with any other party without the prior written consent of each other. The intellectual property rights in respect of the services provided/ Products/ solutions developed by either party shall remain with that party.


6. **FORCE MAJURE:** Neither party shall be responsible for any failure to carry out its commitment due to un-foreseen circumstances or to causes beyond their reasonable control, including but not limited to acts of gods, War, riot, embargos, and acts of civil, or military authorities, fire, floods, energy, labour or materials. In the event of any such delay, parties may defer the date of executing their responsibilities for a period equal to the time of such delay.

7. **VALIDITY:** This MOU shall remain valid initially for period of Five year from the date of signing with an intent to perpetual renewal on expiry, as mutually decided on mutually agreed terms and conditions.


8. **DISPUTES:** This MOU is evolved to undertake serious mission objectives of both parties, based on both, the immediate benefits and on developing enduring institutional relationships serving and safeguarding interests of the parties hereto. Hence any question, doubt or dispute arising out of the interpretation of any terms of usages herein or on the implementation and functioning of the various understandings forming a part of this MOU shall be resolved by the heads of the organizations herein by discussions and negotiations based on consensus in the spirit of developing and strengthening the mutual relationship without any legal implications and with witnesses as arbitrators.


